- **NPEF**- Leticia Truex- the dates are the same and they are virtual this year. July 26-27. Registration is \$30. There will be 10 educational sessions. Adam Tim is opening speaker on both days and Tracy Eldridge will be co-speaker on first day. Theme is Back to the Basics. Next year it will be in Austin where it was supposed to be last year. There was discussion about it being in a bad part of town. Leticia will check with NPEF committee on the location.
